Announcement relating to Premium Income

(the "**Company**" or "**CPIC**") today announces that, for the period between 1 January 2024 and 31 July 2024, the accumulated primary premium income of China Pacific Life Insurance Co., Ltd., a subsidiary of the Company, amounted to RMB170.597 billion, representing a year-on-year decrease of 2.6% and the accumulated primary premium income of China Pacific Property Insurance Co., Ltd., a subsidiary of the Company, amounted to RMB127.650 billion, representing a year-on-year increase of 7.5%.

The accumulated primary premium income referred to above are unaudited. Investors are advised to take note. Announcement is hereby given.

The primary premium income was prepared in accordance with the PRC Accounting Standards for Business Enterprises No. 25 - Original Insurance Contracts (Cai Kuai [2006] No.3) and the Regulations regarding the Accounting Treatment of Insurance Contracts (Cai Kuai [2009] No. 15) of the Ministry of Finance of the People's Republic of China.
2. The accumulated primary premium income of China Pacific Property Insurance Co., Ltd. are the consolidated data including that of Pacific Anxin Agricultural Insurance Co., Ltd., its subsidiary.
